# No More Knives or County Lines



Please note: In all instances where you have an emergency expense issue, such as paying rent, you should contact your local Citizens Advice service and the council.

- **The Trussell Trus**t this charity operates a network of foodbanks and provides confidential crisis support. The school can provide food vouchers for eligible parents to be exchanged for a minimum of three days' emergency food. - **Cost of living payments** a government support package to help mitigate the cost of living crisis. ## Dates for your diary


