REGISTER OF GOVERNORS' AND STAFF BUSINESS AND
PERSONAL INTERESTS 2025/2026

The Fair Funding Scheme for Financing Schools requires all schools to keep a register of any business interest of Governors and Staff employed at the school which should include their immediate families where appropriate. The register should be completed by **all** Governors and staff, retained at the school, kept up to date and complete and open to free inspection by Governors, staff, parents and the Local Authority.

The register will allow all Governors and staff the opportunity to declare any personal potential conflict of interest. The disclosures should also include the following (refer to the guidance notes for further information):

- Any involvement in companies by you and/or close relative – (state company and position),
- Involvement in contracts with the School or the Council by you and/or close relative – (state contract and involvement),
- Governor or Member of another educational establishment,
- Close relative to/relationship with a teacher or Governor/Member at this or any other educational establishment and a senior officer or Elected Member at the Council,
- Beneficial interest in land or property,
- Intent to bid for land or property owned by the Council

It will be necessary for every Governor and member of staff to make an entry even if that entry is simply to register that he/she has no business or personal interests of the school or the Governing Body. **'None'** should be stated if that is the case.
